


Realising the Value of IP

Advantages of a licensing approach


- Permission to copy and maybe to enhance

A Contextualisation

(changes are usually too trivial to give rise to any fresh layer of copyright)

An Enhancement

(substantial Changes - new IP arises, but insertions & deletions unusable apart from original Work)

A Supplementary Work (new IP Arises – the new subject matter is meaningful to some extent, without the original Work)

A Compilation (each item has IP, provided substantial – in addition the Compilation attracts IP because of the effort in selecting & arranging)


